#### INSTRUCTIONS FOR USE

For the disinfection of environments and surfaces DISINFETTO 10 is used at 2% (20 ml of product in 1 liter of water). Pass a cloth previously moistened by the product on the entire surface to be treated and leave it to act. It is recommended to use the product first as a detergent and then follow a second step for disinfection. The solution diluted to 2% can also be used for disinfection in immersion of sanitary equipment. Leave act for 15/20 minutes and rinse with plenty of water before use.
