TECHNICAL DATASHEET

STERMED

STERMED is a registered disinfectant product based on Chlorine with biocidal action against micro-organisms; bactericidal action of Chlorine is more powerful than other oxidant agents, such as hydrogen peroxide for instance. Moreover its active concentration is the lowest among the other oxidizing products.

Thanks to these features, STERMED is suitable for disinfection of hard surfaces, for decontamination of fruit and vegetables and for disinfection of newborn babies objects.



INSTRUCTIONS FOR USE

Disinfection of hard surfaces: dilute to 5%. Contact time 5 minutes.

Decontamination of fruit and vegetables: dilute to 2%. Contact time 15 minutes, then rinse with potable water.

Cleaning and preservation of feeding bottles, newborn babies objects, dishes used in neonatal age: dilute to 2%. Contact time 30 minutes, allow to soak until use, rinse with plenty of potable water.

COMPOSITION

100,00 g of product contain:

Sodium Hypochlorite 1,15 g (equivalent to active Chlorine 1,10 g); coformulants, deperated water q.s. to 100,00 g.

PRODUCT FORM

Light straw-colored clear liquid, light smell of chlorine.

ACTIVITY

The action spectrum is wide and includes Gram-positive, Gram-negative bacteria, Fungi, Mycobacterium, Viruses (HBV, HCV, HIV). The Chlorine microbial activity is higher if pH decreases.

WARNINGS

STERMED can bleach some tissues and release dangerous gases (chlorine). Do not use in combination with other products. Hold away from food and animal feeds.

VALIDITY

30 months. The indicated period of validity refers to the product stored in its container and properly used and stored.

HOW TO STORAGE

Store in a cool, dry place, away from heat sources.
