Its formula optimizes the compatibility with equipment and all materials in use at nursing homes, dental clinics, medical surgeries, hospitals, beauty centers, etc. The particular formulation of GERMOCID TEC is suitable for alcohol-sensitive surfaces and materials such as: beds, cots, litters, facial masks, objects and plexiglass equipment. INSTRUCTIONS FOR USE
